#### <u>Statement from Acting DEC Commissioner Basil Seggos on</u> <u>Passing of Former Commissioner Henry Diamond</u>

"The Department of Environmental Conservation is deeply saddened by the passing of our first commissioner Henry L. Diamond, who served the state with great distinction from 1970 to 1973. "Appointed by Governor Nelson Rockefeller as the agency's first commissioner on the first Earth Day, Henry was a pioneer and steadfast champion for the environment during a period when government agencies were slow to recognize the need to combat air and water pollution.

"In his capacity at the DEC, he combined all New York State resource management and anti-pollution programs into the nation's first environmental department. Henry was at the forefront of creating programs to deal with mercury pollution and solid waste management, initiatives which later became models for many other states.

"For more than 60 years he devoted his life to public service and protecting our natural resources with a focus on leading by example. It's clear that New Yorkers and the environment are better off because of his efforts, and when the history of New York State environmentalism is written, the name Henry Diamond should be at the forefront.

"Our thoughts and prayers are with Henry's wife Betty and the Diamond family."

### DEC Proposed 2017 Freshwater Fishing Regulation <u>Changes Now Available for Public Review</u> <u>Anglers Are Encouraged to Review and Comment on</u> <u>Potential Changes</u>

Based on the State's ongoing monitoring of New York's freshwater fish populations and discussions with anglers, the New York State Department of Environmental Conservation (DEC) has identified potential changes to the fishing regulations and is seeking additional angler feedback. Changes being considered to the <u>current freshwater fishing regulations</u> are now available at DEC's website, and if approved, these regulation changes would take effect on April 1, 2017.

Many of the changes being considered are intended for safeguarding and/or expanding fish populations while enhancing angling experience and enjoyment. Other changes under consideration are focused on eliminating special regulations that did not achieve their intended purpose, in a continuing effort to simplify New York fishing regulations. Proposed warmwater regulation changes include temporarily adjusting creel and minimum size limits for walleye as part of DEC's multi-year effort to establish walleye populations in candidate waters, as well as protecting walleye where they congregate during the spawning season. Coldwater regulation changes being considered involve the adjustment of creel limits for walleye and minimum size limits for select waters based on recent biological assessments.

Following the review of the public feedback received and further evaluation this winter, DEC will advance proposals that have general angler acceptance and are likely to result in better fishing. The proposals will be advanced in accordance with New York State's rule making process, and will include a formal public comment period. At this time, DEC is soliciting initial feedback on what may be proposed later this year. Input will be accepted through March 31.

DEC welcomes and encourages feedback on the regulation changes currently under consideration. To view these potential changes and to provide input, visit the DEC website.
